PART I - GENERAL TERMS AND CONDITIONS

1. APPLICATION

- 1.1 Requirement, agency candidate(future agency manager) must submit list of no less than 10 active hosts' Mika IDs and fulfill the registration form.
- 1.2 Channel, print all pages of the present whole policy, fulfill the registration form, hand-sign in every page and for India send it via mail to india@livetalklife.com, together with agency manager national ID card picture and the list of above mentioned hosts list. Lack of any document will cause rejection of agency application.
- 1.3 Mika Official will reply within 5 working days during which evaluation and necessary investigation might be carried on. Mika Official has the total right to approve or reject agency application.
- 1.4 Agency applicant must not be verified host of any existing agency in any form.
- 1.5 Information submitted with application is the only valid data of agency in front of Mika, any change related to it must be applied via mail with the same applicant email address and approved by Mika.

2. TARGET

From the second month of its approval, agency must comply 20 effective hosts and 500,000 diamonds of all its hosts combined as minimum target. Non-accomplishment with two months may lead to agency termination. With less than 10 effective hosts, agency share and any benefits associated in that month will not be paid.

3. LIMIT

3.1 Agency manager is the only responsible for his agency, responsible for any behaviors of his manager, recruiter, coin seller and hosts. Agency manager and its recruiters must transfer and

explain Mika policies including but not limited to Host Monthly Policy to its hosts.

- 3.2 Agency manager must give Mika Official proofs of payments to hosts in case Mika pays host salary through agency manager or its recruiter due to any circumstance. Agency manager or recruiter can never hold nor delay to pay host salary under any scenario.
- 3.3 It is mandatory for agency manager and its recruiters to be good example of its hosts, including but not limited to following Mika Community rules / no dark no black screen live/anti-fraud etc, serious violation conducted by agency members can lead to ID ban/fine/partial payment or no payment/agency termination, charge back all corresponding historic shares already paid to agency manager to depending on its offensive level and Mika independent judgement.

4. TERMINATION

On its own decision and judgement Mika Official reserves its right to terminate agency when below scenario occurs:

- 4.1 When agency manager applies termination.
- 4.2 When agency hasn't complied minimum target as in TARGET condition defined.
- 4.3 When heavy fraud or/and infringement is conducted by agency manager.
- 4.4 When Mika feels agency is a potential threat to Mika or its business or society.

5. Others
